It's Nomination Time

Dear Lake County Mounted Posse Members:

In November of this year, potential new Officers will be elected to the Lake County Mounted Posse. We are in search of possible candidates to run for these available positions and volunteer their time in helping the Posse grow and continue to encourage the motto of "Horsemanship, Sportsmanship and Citizenship".

The next several years promise to be exciting ones for the Lake County Mounted Posse. The organization will continue to have a positive impact on the communities we serve. The Officers will play a central role in this. Your experience and involvement in these roles help to keep the Posse active and progressing towards the future.

A primary responsibility of Officers is to participate in the development of policy and major decision-making at board meetings held once a month. Another key responsibility is to be active on an ongoing basis in a committee of the board.

Current positions and descriptions available as follow:

PRESIDENT: The President shall preside at all meetings of the Club and the Board of Directors: enforce all laws, rules and procedures of the Club; be an ex-officio member of all committees except the nominating committee; oversee bills to be paid by the Treasurer and shall countersign checks drawn on the Club funds. The President shall appoint the chairman of all committees with the approval of the Board of Directors, and make, execute and deliver all contracts i.e. insurance renewal on behalf of the Club with the approval of the Board of Directors, unless someone in specific instances is authorized to enter into contractual agreements on behalf of the Club. The President will transfer all files, legal papers, electronic records and logon information to the successor President no later than January 15th.

VICE PRESIDENT: The Vice President in the absence of the President shall perform the duties of the President. If neither is present at any meeting, a chairman shall be chosen by remaining Officers and Directors.

SECRETARY: The Secretary, in accordance with the direction of the President and/ or Board of Directors, shall conduct all official correspondence i.e. Monthly Newsletter, of the Club; keep all records, including minutes of all meetings of the Club and the Board of Directors; issue and send all notices to the members and prepare Annual Statement of Incorporation. The Secretary shall keep attendance records and tally votes from Board and General Meetings. The Secretary shall also receive applications for membership, make investigations as to the eligibility of applicants and report thereon to the Board of Directors, and maintain accurate records regarding the membership of LCMP. The Secretary will transfer all files, legal papers, electronic records and logon information to the successor Secretary no later than January 15th.

TREASURER: The Treasurer shall keep all accounts of the Club. The Treasurer shall receive and be responsible for all the monies; pay all bills when properly audited and approved by the Board of Directors and present vouchers for all payments. Checks shall be signed by the Treasurer and countersigned by the President. Accounting records shall be available for inspection to any and all members of the Board or individual members in the presence of a Director. The Treasurer shall submit a written detailed report of the financial transactions at the monthly membership meetings and Board of Directors meetings and provide a yearly summary of receipts and expenditures for the period of the term of the office. The Treasurer shall file the appropriate Internal Revenue forms with the Internal Revenue Service at the end of each calendar year. The Treasurer shall be responsible for the year end LCMP inventory / asset list.

If you have any interest in these positions, please contact Kelsey Mascorro. She will compile the list of candidates and introduce them at the next October General Meeting. Also, at the October General Meeting, you will give an introduction/mini biography about yourself and why you would be a great candidate for the position.
